[MOEF] Treasury Bond Issuance Plan, September 2018 (August 24)

The Ministry of Economy and Finance plans to issue Korea Treasury Bonds worth approximately 5,600 billion won (excluding 50-year KTB) in September 2018 through competitive bidding. More

[MOEF] External Debt, Q2 2018 (August 22)

Korea's external debt amounted to US \$440.5 billion as of the end of June 2018, an increase of US \$6.7 billion from the previous quarter. <u>More</u>

[BOK] Trade Indices and Terms of Trade Indices, July 2018 (August 24)

The net barter terms of trade index decreased by 9.7 percent year-on-year in July 2018. More

[BOK] Household Credits, Q2 2018 (August 23)

Total household credits outstanding increased by 24.9 trillion won in the second quarter of 2018 to stand at 1,493.2 trillion won as of end-June, with household loans totaling 1,409.9 trillion won and merchandise credits 83.2 trillion won. More

[BOK] International Investment Position, End of June 2018 (August 22)

As of the end of June 2018, Korea's net international investment position (net IIP) was \$321.1 billion (preliminary), up \$44.6 billion over the quarter (from the end of March 2018). More

[BOK] Producer Price Index, July 2018 (August 21)

The Producer Price Index increased by 0.4 percent month-on-month in July 2018 and by 2.9 percent year-on-year. More
