
Interest Rates: July 2019

- ☐ In July 2019, the average interest rate on new deposits was 1.69%, down 10 basis point from the previous month.
 - The average interest rate on outstanding amounts of deposits as of end-July stood at 1.39%, down 1 basis point from the previous month.
- ☐ In July 2019, the average interest rate on new loans registered was 3.40%, down 9 basis point from June 2019.
 - The average interest rate on outstanding amounts of loans as of end-July was 3.63%, down 5 basis point from the previous month.

Notes to interest rates statistics

☐ The interest rates on outstanding deposits/loans are weighted averages
of the interest rates applied to the stock of all deposits/loans as of
the end of the month.
 These statistics give information about changes in the interest rate margins and profitability of banks, as well as the amount of interest paid or received by households and corporations.
☐ The interest rates on new deposits/loans are weighted averages of
the interest rates specified in new agreements during the reference
month.
 These statistics show the current lending and deposit interest rates faced by households and corporations, which provide useful information for customers in making financial decisions.
